## ACTION ITEMS

- A. **Adopt Resolution 06-2017 Amending the FY2017-2021 Regional Transportation Improvement Program**

Toni Tisdale presented Resolution 06-2017 amending the FY2017-2021 Regional Transportation Improvement Program adding a rehabilitation segment on the Broadway Bridge near Boise State and pavement rehabilitation at I-84 Sand Hollow Interchange to SH44, as recommended by RTAC for COMPASS Board adoption.

After discussion, **Darin Taylor moved and Garret Nancolas seconded adoption of Resolution 06-2017 amending the FY2017-2021 Regional Transportation Improvement Program as presented. Motion passed unanimously.**

- B. **Adopt Resolution 07-2017 Approving Revision 2 of the FY2017 Unified Planning Work Program and Budget**

Megan Larsen presented Resolution 07-2017 approving Revision 2 of the FY2017 Unified Planning Work Program and Budget adding funds to two programs and moving funds in four programs, as recommended by the Finance Committee for COMPASS Board approval.

After discussion, **Darin Taylor moved and Elaine Clegg seconded adoption of Resolution 07-2017 approving Revision 2 of the FY2017 Unified Planning Work Program and Budget as presented. Motion passed unanimously.**

**C. Accept 2017 Population Estimates**

Carl Miller presented 2017 population estimates for COMPASS Board acceptance, which are used for local and regional planning and as a factor to help establish COMPASS membership dues, and recommended for COMPASS Board approval by the Demographic Advisory Workgroup.

After discussion, **Darin Taylor moved and Joe Stear seconded acceptance of the 2017 population estimates as presented and will be recalibrated after the 2020 Census. Motion passed unanimously.**

**D. Approve FY2018 General and Special Membership Dues**
