Topic: COMPASS Regional Safety Action Plan

Request/Recommendation:

COMPASS staff seeks RTAC recommendation to the COMPASS Board of Directors to adopt Resolution X-2025 (attached) and the Regional Safety Action Plan (RSAP).

Background/Summary:

The Safe Streets and Roads for All (SS4A) program was developed as part of the 2021 Infrastructure Investment and Jobs Act. The program dedicated \$5 billion from 2022-2026 to fund transportation safety planning and projects. The SS4A program is broken into two types of monetary awards: planning and implementation. The first year of the program is focused heavily on awarding funds to produce transportation safety plans. A thorough plan is required to access the implementation awards. COMPASS, with the support of all its member agencies, applied for and was awarded \$392,000 (80% of total project cost) in 2023 to complete a regional safety action plan.

Over the last 14 months, COMPASS, with support from Kittelson and Associates, High Street Consulting, Atlas, and a workgroup of 40 staff from partner agencies completed the Regional Safety Action Plan (RSAP).

The RSAP includes the following items:

- Vision, goals, targets, and performance measures that support the elimination of serious and fatal injury crashes.
- Review of current transportation safety practices in the region.
- Extensive evaluation of serious and fatal crashes from 2018-2022 in the region.
- A high injury network was developed using crash history in conjunction with identified risk factors.
- Results of public engagement opportunities.
- Toolkit of proven transportation safety measures to address regional crash trends.
- Strategies and actions necessary to implement the vision and goals of the plan.
- Concepts for projects that utilize the tools and practices outlined in the plan and could be pursued through the SS4A program or other federal grant opportunities.

The RSAP also includes a resolution committing COMPASS and its regional partners to the vision, goals, and targets to achieve a 50% reduction in serious and fatal injury crashes by 2055. This component of the plan fulfills one of several requirements necessary to pursue implementation grants through the SS4A program.

Implication (policy and/or financial):

Adoption of Resolution X-2025 approving the RSAP enables COMPASS and its member agencies to pursue SS4A implementation federal grant opportunities.

The strategies, actions, and practices outlined in the plan will guide/inform future tasks for COMPASS staff/workgroups, the Unified Planning Work Program and Budget, performance measures, and project scoring in the Transportation Improvement Program and Communities in Motion 2055.

RESOLUTION NO. XX-2025

FOR THE PURPOSE OF REGIONAL COMMITMENT TO ELIMINATE FATALITIES AND SERIOUS INJURIES ON ADA COUNTY AND CANYON COUNTY ROADWAYS THROUGH INNOVATION, COLLABORATION, EDUCATION, AND ENGAGEMENT.

WHEREAS, the Community Planning Association of Southwest Idaho (COMPASS) has been designated by the Governor of Idaho as the metropolitan planning organization responsible for transportation planning in Ada and Canyon Counties; and

WHEREAS, COMPASS was awarded a federal Safe Streets and Roads for All (SS4A) planning grant to fund a Regional Safety Action Plan (RSAP) to identify measures for reducing fatal and serious crashes for all modes – vehicles, motorcycles, pedestrians, and bicyclists; and

WHEREAS, to comply with the SS4A program requirements, the RSAP must include a public commitment to the eventual goal of zero roadway fatalities and serious injuries from a high ranking official and/or elected body in the jurisdiction, including a timeline/target for achieving that goal; and

WHEREAS, progress toward the national safety goals is monitored as part of the Federal Highway Administration's annual Safety Performance Measurement reporting process; and

WHEREAS, the Vision for the Idaho Transportation Department's Strategic Highway Safety Plan is "Continue to move toward zero deaths on all roadways in Idaho" and its goal is to reduce traffic deaths in Idaho to 230 or fewer by 2025; and

WHEREAS, the likely timeframe from RSAP adoption to project programming, design, funding, and construction will exceed six (6) years in most cases; and

WHEREAS, under the SS4A grant program, establishing multiple target dates to achieve zero fatal and serious injury crashes is allowable; and

NOW, THEREFORE BE IT RESOLVED, that the COMPASS Board of Directors: Commits to elimination of fatalities and serious injuries on its roadways through innovation, collaboration, education, and engagement; and agrees to plan and program projects to achieve the interim target of a 50 percent reduction in fatal and serious-injury crashes by 2055.

Topic: Balancing in the Transportation Management Area (TMA)

Request/Recommendation:

COMPASS staff requests RTAC approval to balance the Surface Transportation Block Grant (STBG)-TMA and Transportation Alternatives Program (TAP)-TMA to make program adjustments at the request of sponsor agencies.

Background/Summary

Although federal programs are operating on a Congressional continuing resolution, which only provides formula funding through December 20, 2024, COMPASS budgets up to 100% of the estimated allocations with the expectation that funds will eventually become available. Currently, the STBG-TMA and TAP-TMA programs have unbudgeted funding, as well as released funds from two close out projects.

Current project needs are tracked throughout the year on the Needs List (Attachment 1). Some funds and adjustments are needed in future years, which are included on the Needs List, but will not be processed until the spring during the update process to the regional transportation improvement program. The current needs for balancing are summarized below:

- Access to Opportunity, Boise and Garden City (ACHD) (Key Number 23833)
 - o Requested \$381,000 to convert advanced construction funds for design
- Fairview Avenue, North Garden to Whitewater Park and Bridge Replacement (ACHD) (Key Number 24382)
 - o Requested \$1,800,000 to convert advanced construction funds for design
- Transit State Street Premium Corridor, Part 2, Boise Area, VRT (Key Number 23179)
 - Requested \$354,420 to cover a shortfall for construction funds in the project funded through a RAISE grant
 - o The original request was for a total of \$1,264,420, partially funded in FY2024

Priorities are based on Board Policy 2024-03, "Balancing Surface Transportation Block Grant Program (STBG), Transportation Alternatives Program (TAP), and Carbon Reduction Program (CRP) Funds," approved by the COMPASS Board of Directors on August 19, 2024. The policy is available on the COMPASS website (link provided below). The two ACHD projects are tied using the priorities in the balancing policy. After discussion with ACHD, the projects are listed in ACHD's order of preference.

The proposed changes are shown in detail on the TMA balancing worksheet, provided in the RTAC supplemental (link below). Letters of request from sponsoring agencies, including more details about the requests, are provided in Attachment 2.

Implication (policy and/or financial):

The recommended actions allow the obligation of available STGB-TMA and TAP-TMA program funds in FY2025.

SUMMARY:

VRT included improved pedestrian facilities and bus stop infrastructure at State and 23rd and State Street and 27th in its FY2022 RAISE grant application (Key number 23179). The cost estimates in the RAISE grant were based on high level concepts and focused on the transit amenities. As VRT worked with the City of Boise and ACHD to complete preliminary engineering it has became clear that there would be additional costs not anticipated in the original RAISE grant. These additional scope items include a complete signal replacement, which will result in upgraded signal equipment to meet current standards and upgrading pedestrian ramps and ADA facilities on all corners. These changes also resulted in additional right of way impacts and stormwater facility impacts.

VRT anticipates being able to cover some of these additional costs by rebalancing the RAISE funds however, the current cost estimate will exceed RAISE funding for these two projects by an estimated \$1,264,420 and is requesting STBG funds to cover this short fall. Any amount towards this shortfall will be useful to advance the project.

State and 23rd Street

There are sufficient RAISE funds for \$1,370,650 to go to State and 23rd. The current cost estimate is \$1,889,580 leaving a \$518,930 shortfall.

State and 27th Street

There are sufficient RAISE funds for \$903,000 to go to State and 27th. The current cost estimate for State and 23rd is \$1,648,490 leaving a \$745,490 shortfall.

Topic: High-Capacity Transit (Let's Ride Treasure Valley) Planning and Environmental Linkages (PEL) Study Public Comments Received to Date

Request/Recommendation:

This is an information item only.

Background/Summary:

In January 2024, COMPASS began the High-Capacity Transit (Let's Ride Treasure Valley) PEL Study. Consistent with the regional vision and goals outlined in *Communities in Motion 2050*, this study examines a future high-capacity transit connection west to east across Canyon and Ada Counties south of the Boise River. From September 22 to October 11 COMPASS held a public comment period on the purpose and need for high-capacity transit, range of routes, and Tier 1 screening results. As part of the public outreach, public meetings were held in Boise on September 24, 2024, and in Caldwell on September 25, 2024. A detailed summary of the public comments received is provided in the RTAC supplemental (link below).

In total, COMPASS received 341 survey responses and 26 comments via email. In general:

- More than 90 percent of respondents agreed or mostly agreed with the questions asked.
- Public support and agreement with the purpose and need was very strong with only two to four percent of respondents indicating that they were not in agreement with elements of the purpose and need.
- Respondents ranked "expanding travel choices and mobility" and "improving transit connectivity and mode share" as top goals for the service.
- Four to seventeen percent of respondents disagreed with or suggested changes to the objectives for the service; suggested changes will either be included in a future phase of the study or are out of scope of analysis.
- Seven to twenty-nine percent of respondents disagreed with not advancing Chinden Boulevard, Ustick Road, Overland Road, and Victory/Powerline Road to Tier 2.
 Commenters suggested keeping these routes due to significant population growth along those corridors. The project team has identified that while population growth is expected, these corridors did not connect destinations with the high likelihood of transit use, such as downtowns.

In sum, the project team did not find the comments received warranted changes to the purpose and need for high-capacity transit, range of routes, or Tier 1 screening results.

Topic: COMPASS Phase II Application Cycle

Request/Recommendation:

Information/discussion.

Background/Summary:

COMPASS holds an annual call for project applications each fall. For the 2024 call for projects, applications awarded federal funds will be included in the FY2026-2032 Transportation Improvement Program (TIP). Though the funding period covered by the FY2026-2032 TIP begins October 1, 2025, most new projects will be budgeted in the last year(s) of the TIP.

To assist member agencies in submitting successful applications, COMPASS develops the COMPASS Funding Application Guidebook (recommended by RTAC in July and approved by the COMPASS Board of Directors in August) and provides several tools and resources that should be used to prepare and submit a strong application. The goals and vision of *Communities in Motion 2050* should drive your application.

To assist you in preparing a quality application, COMPASS will share how to approach the FY2024 call for projects and discuss important components of your application, including those listed below.

Phase II Application

 Requests all federally required project information. COMPASS staff will notify the project sponsor if the project is eligible for federal funding and a Phase II application is needed.
 Due: 1/21/2025

Scoring Criteria

- Each project type relies on different types of criteria. Pay attention to the selection criteria and information needed for your type of project:
 - Roadways/Bridges
 - Active Transportation
 - Public Transportation
 - Planning/Special Projects
- Continually refer to the scoring criteria for the specific project type as you fill out the
 application and provide all the required information to receive the best score possible.
 COMPASS staff will provide preliminary scores based on the Phase I application for your
 convenience.

Topic: COMPASS 50-State Transportation Funding Study

Request/Recommendation:

This is an information item only.

Background/Summary:

In 2022, COMPASS calculated a \$193 million annual shortfall in transportation funding for Ada and Canyon Counties to the year 2050. The shortfall is comprised of unfunded needs across all types of transportation infrastructure. Many factors contribute to this shortfall, including a static fuel tax, fuel-efficient vehicles, and inflation.

In fall 2023, COMPASS, with consultant WSP, initiated a study to better understand how other state and local governments are funding their transportation systems to inform local and statewide funding policy discussions. The study, completed in October 2024 and posted on the COMPASS website (see "More Information," below), focused on four main topic areas:

- Local transportation funding mechanisms
- Public transportation funding mechanisms
- Suballocation of federal Surface Transportation Block Grant (STBG) funding to local jurisdictions
- Adoption of Road Usage Charges (RUC) to offset decreasing fuel taxes due to high fuel-efficient vehicles

Key takeaways from each of these topic areas are described below and will be shared in more detail in the meeting.

Local Transportation Funding

- Forty-two states, including Idaho, allow the use of local property tax to fund local transportation infrastructure.
- Vehicle registration fees and impact fees are the two most common local <u>fees</u> used to fund transportation.
- Of 11 local taxes and fees evaluated, three were determined to be sufficient on their own to address the Treasure Valley's \$193 million annual shortfall: local option sales tax, property tax, and income tax.

Public Transportation Funding

- Idaho and West Virginia are the only states that do not allow local revenue generating options for public transportation nor provide meaningful state funding.
- National trends reflect a growing commitment to improving public transportation infrastructure and services. Several states have recently enacted significant legislative measures and/or allocated substantial funds to enhance transit systems.
- Local option sales tax and property tax are the most promising revenue streams for dedicated, long-term funding.
- Location-specific funding, such as through special assessment districts, could augment these taxes for discrete, location-specific infrastructure, such as bus stops.

Suballocation of Federal Funds

- More than 83% of states suballocate 55% or more of their STBG funding to local jurisdictions;
 Idaho suballocates about 51%.
- More than 81% of states use the recommended federal computational tables to allocate federal funds to local jurisdictions; Idaho does not.
- States are more likely to suballocate money to local jurisdictions in larger regions, and more likely to spend the funding on state projects that benefit the region in smaller regions.

Road Usage Charges

- Three states have active RUC programs: Oregon, Utah, and Virginia. Many other states have ongoing or completed pilot projects.
- In Utah and Virginia, the programs serve as alternatives to flat fees imposed on electric and other
 alternative fueled vehicles. Vehicle owners can choose between the flat fee or the RUC. If the RUC
 is selected, the total cost to the vehicle owner cannot exceed the flat fee rate.
- In Oregon, the program is a voluntary alternative to fuel taxes where drivers receive credit for fuel taxes paid at the pump.
- Barriers include privacy concerns, compliance, and cost. Solutions to address these barriers include providing a variety of technology options and using private vendors.
