March Action Items:

- April Board Meeting Agenda. Established the agenda for the April 17, 2023, COMPASS Board of Directors meeting.
- <u>Title VI</u>. Recommended COMPASS Board of Directors' approval of COMPASS' updated Title VI Plan. This Title VI Plan update will fulfill a recommendation from the Federal Highway and Transit Administrations made as part of COMPASS' 2022 Transportation Management Area Planning Certification Review. This item will be brought to the COMPASS Board of Directors for action via Consent Agenda in its April 17, 2023, meeting.
- <u>2023 Idaho Legislative Activity</u>. Received an overview of legislation introduced to date and directed COMPASS staff to remain neutral on, but monitor, House Bills HB310 (Countywide Highway Districts Carpool, Vanpool, Ridesharing, and Park and Ride Programs), HB263 (Countywide Highway Districts Subdistricts), and HB292 (Property Tax Relief).
- <u>Board Member Travel</u>. Approved a travel request for Mayor Trevor Chadwick to attend the National Association of Regional Councils' 2023 Annual Conference, June 4 7, 2023, in Detroit, MI.

March Action Items:

- TMA Balancing. Recommended balancing the Transportation Alternatives Program (TAP) in the Transportation Management Area (TMA) by allocating available funding to the City of Boise to advance and combine two pathway improvement projects along State Highway 55.
- <u>Federal-Aid Programs</u>. Recommended updates to formula-based federal-aid programs (Surface Transportation Block Grant [STBG]-TMA, TAP-TMA, STBG-Urban, Carbon Reduction Program [CRP]-TMA, and CRP-Urban) for FY2024-2030 to be included in the draft FY2024-2030 Regional Transportation Improvement Program (TIP). The full draft FY2024-2030 TIP will be brought to RTAC for review in its May 24, 2023, meeting.
- <u>FY2023-2029 TIP.</u> Recommended COMPASS Board of Directors' adoption of a Board Administrative Modification to the FY2023-2029 TIP to increase the cost of four Valley Regional Transit projects and to increase the cost and advance a COMPASS project to develop a Regional Safety Action Plan. COMPASS received a nationally competitive grant to develop this plan, allowing it to be advanced. This item will be brought to the COMPASS Board of Directors for action in its April 17, 2023, meeting.
- <u>UPWP</u>. Recommended priority rankings of member agency requests for COMPASS' FY2024 Unified Planning Work Program and Budget (UPWP). The COMPASS Finance Committee will balance the priorities with available resources and recommend a final UPWP for COMPASS Board of Directors' approval in August.
- <u>High-Capacity Transit PEL Study.</u> Recommended COMPASS Board of Directors' acceptance of a draft scope of work for a high-capacity transit Planning and Environmental Linkages (PEL) study to be used in a future Request for Proposals, as recommended by the Planning and Environmental Linkages Workgroup. This item will be brought to the COMPASS Board of Directors for action in its April 17, 2023, meeting.
- <u>Safety Targets</u>. Recommended COMPASS Board of Directors' adoption the Idaho Transportation Department's (ITD's) annual statewide safety performance targets. Per federal law, metropolitan planning organizations, such as COMPASS, must establish annual safety targets, either by supporting statewide targets or setting regional targets. This item will be brought to the COMPASS Board of Directors for action in its April 17, 2023, meeting.
