Communities in Motion 2040 2.0 Development Review

The Community Planning Association of Southwest Idaho (COMPASS) is the metropolitan planning organization (MPO) for Ada and Canyon Counties. COMPASS has developed this review as a tool for local governments to evaluate whether land developments are consistent with the goals of *Communities in Motion 2040 2.0* (CIM 2040), the regional long-range transportation plan for Ada and Canyon Counties. This checklist is not intended to be prescriptive, but rather a guidance document based on CIM 2040 2.0 goals.

Recommendations

Both Midland Boulevard and Cherry Lane are listed as priority, unfunded corridors in the *Communities in Motion 2040 2.0* plan. Midland Road, from Cherry Lane to US 20/26, is planned to be widened to five lanes. It is the #8 highest-ranked local unfunded corridor. Cherry Lane/Fairview Avenue, from Middleton Road to Black Cat Road, is also planned to be widened to five lanes and is the #9 local priority. Valley Regional Transit route #42 provides regional bus service between the Happy Day Transit Center and the Boise Towne Square Mall and serves the corner of Midland Boulevard and Cherry Lane. Work with Valley Regional Transit on design that would accommodate future service. The proposal is a mix of residential and retail, which can mitigate the increase of traffic congestion by encouraging non-motorized travel and shorter trips. The mix of housing stock which may enable many types of households to live in the neighborhood.
