## Communities in Motion 2040 2.0 Development Review

The Community Planning Association of Southwest Idaho (COMPASS) is the metropolitan planning organization (MPO) for Ada and Canyon Counties. COMPASS has developed this review as a tool for local governments to evaluate whether land developments are consistent with the goals of *Communities in Motion 2040 2.0* (CIM 2040), the regional long-range transportation plan for Ada and Canyon Counties. This checklist is not intended to be prescriptive, but rather a guidance document based on CIM 2040 2.0 goals.

## Recommendations

This proposal is served by Valley Regional Transit, bus route #9, with a bus stop at the northeast corner of State Street and Ballantyne Lane. At this location the bus provides 30 minute-frequencies during the peak commute hours. Work with Valley Regional Transit on station location and amenities to best connect nearby neighborhoods to this station. The proposal includes stub roads to the north and to the east to promote automobile and non-motorized connectivity.
