Recommendations

The proposal requests additional vehicle access to Black Cat Road, a minor arterial. Consider a shared access to West Victory Road, also a minor arterial, or a shared access for Lots 2 and 3 to Black Cat Road. Additional access locations can reduce efficiency on the corridor.

This location is still in a largely farmland area. Nearby services, such as schools, parks, emergency services, grocery, and other stores are likely accessed only by vehicle and there are no plans for public transportation to this location.
