

Communities in Motion 2040 Development Review

The Community Planning Association of Southwest Idaho (COMPASS) is the metropolitan planning organization (MPO) for Ada and Canyon Counties. COMPASS has developed this review as a tool for local governments to evaluate whether land developments are consistent with the goals of *Communities in Motion 2040 (CIM 2040)*, the regional long-range transportation plan for Ada and Canyon Counties. Walking and biking reduces congestion by taking cars off the road, while supporting a healthy and active lifestyle.</p>

Recommendations

Consider providing an improved path along the New York Canal. Internal sidewalk connections to Touchstone Drive would reduce the network distance to Desert Sage Elementary School and neighborhood parks.

Providing public transportation to this proposal is problematic. Work with Valley Regional Transit on design that would accommodate future service.
