Communities in Motion 2040 2.0 Development Review

The Community Planning Association of Southwest Idaho (COMPASS) is the metropolitan planning organization (MPO) for Ada and Canyon Counties. COMPASS has developed this review as a tool for local governments to evaluate whether land developments are consistent with the goals of *Communities in Motion 2040 2.0* (CIM 2040), the regional long-range transportation plan for Ada and Canyon Counties. This checklist is not intended to be prescriptive, but rather a guidance document based on CIM 2040 2.0 goals.

Recommendations

The *COMPASS 2022-2028 Regional Transportation Improvement Plan* identifies several planned transportation projects near the proposal including pavement rehabilitation and construction of shared-use shoulders on Midway Road (see Figure 1) as well as the widening of Karcher Road (SH-55) in 2027 (see Figure 2).

The proposal is about 2-miles from several transit routes including a park and ride location at Karcher Mall and a bus stop at Nampa/Caldwell Blvd. & Karcher Rd. The stop is currently served by Route 40 (Nampa/Meridian Express), which provides service from Nampa to Boise State University.

Construction of Farmway Road to 10th Avenue is unfunded.

The purpose of the fiscal impact analysis is to better estimate expected revenues and costs to local governments as a result of new development so that the public, stakeholders, and the decision-makers can better manage growth.
