Recommendations

There are two relevant transportation projects near the proposal in the FY2018-2022 Regional Transportation Improvement Program (TIP):

- Widening of Linder Road to 5 lanes, from Franklin Road to Pine Avenue, scheduled for 2020 (Key Number RD213-16).
- Installation of new crossing signals and gates at the railroad crossing at Linder Road, scheduled for 2020 (Key Number 19875).
