So, I opted to enter my comments through email. Comments are as follows: The Rainbow Bridge north of Smith's Ferry was constructed in 1933! This bridge is 90 years old and has clearly outlived its economic usefulness. This bridge needs to be replaced! The Rainbow Bridge, built by 1933 standards, has narrow lanes, the difference between traffic at that time compared to traffic in 2023. Vehicles today are much different than the vehicles of yester-year, including bigger trucks, semi-truck traffic, recreational vehicles, as well as construction equipment. I envision a new more modern bridge, wider lanes and road construction taking out the sharp curve on the north end of the bridge. With a longer span, exiting the bridge from south to north could be a straighter shot up the hill rather than dealing with two 25 MPH curves that are currently involved. The road construction that has been ongoing on the south side of the river gives this project a great opportunity for improvement, enhancing safer driving, just like the bridge that was replaced north of Riggins several years ago. Additionally, bridge improvements in Cascade and Horseshoe Bend greatly improved safer driving with wider lanes and eventual four-lane availability for future use. The Rainbow Bridge has endured cosmetic repairs over the past several years, none of which improved safer driving conditions. This bridge, regardless of the historic preservation desires, needs to be replaced and a newer more modern bridge constructed in its place. Vehicle safety for the constant Boise to McCall travel, especially during summer months, should make this need obvious. I did not see the Rainbow Bridge specifically mentioned in the ITD portal of information and believe that it should have been a significant priority.

A review of the ITD DRAFT seven-year budget indicates the only work planned for Hwy 55 in Boise County is tree removal from MP 68-79 that is currently in progress. This is very discouraging because weekend and holiday access to Hwy 55 southbound at the Banks/Lowman Road intersection for Garden Valley residents (such as me) and visitors remains very difficult and often results in an hour or more delay. This is not a new problem, but it does continue to worsen each year and the number of days flaggers are required has more than doubled. About 5 years ago I attended a public meeting at the Garden Valley High School that was conducted by several ITD executives who indicated the problem was recognized by ITD and ensured us they were actively pursuing land swaps so the intersection could be widened, and improvements made to eliminate the problem. At that time, it was explained the reason a stoplight could not be installed was because the bridge extending west from the intersection across the North Fork of the Payette is only one lane. Now, 5 years later it appears the ITD has forgotten its commitment to the residents of Garden Valley because the ITD 7-year plan does not include any funding for improving our access to Hwy 55 on weekends.
