- <u>December Board Meeting Agenda</u>. Established the agenda for the December 18, 2023, COMPASS Board of Directors meeting.
- <u>2024 COMPASS Board Officer Slate</u>. Recommended COMPASS Board of Directors' approval of the following slate of officers for 2024: Chair, Mayor Trevor Chadwick; Chair Elect, Commissioner Jay Gibbons; Vice Chair, Commissioner Rod Beck; Secretary/Treasurer, Mayor Jarom Wagoner; Immediate Past Chair, Mayor Debbie Kling. The Board of Directors will be asked to approve the recommended officer slate in its December 18, 2023, meeting.
- <u>Board Member Travel</u>. Approved a travel request from Mayor Trevor Chadwick to attend the National Association of Regional Councils' 2024 National Conference of Regions, February 11 15, 2024, in Washington, DC.

• <u>Member Service Request</u>. Reviewed a membership services request from the City of Nampa to assist in determining support for a Canyon County-wide local option registration fee and associated next steps.

November Action Items:

- <u>Vice Chair</u>. Elected Doug Hanson, City of Kuna, as Vice Chair for the remainder of 2023, as the previous Vice Chair, Miranda Carson, is no longer a member of RTAC.
- <u>TIP Amendment Policy</u>. Recommended COMPASS Board of Directors' approval of changes to the regional transportation improvement program (TIP) amendment policy to more closely align with the Idaho Transportation Department's statewide TIP amendment policy and incorporate changes requested by federal transportation agencies.

- <u>CIM 2055</u>. Discussed revised proposed goals and objectives for *Communities in Motion 2055* (CIM 2055) and delayed action to a future meeting to allow time for additional discussion of questions and edits proposed in the meeting.
- TMA Balancing. Recommended actions to balance the Surface Transportation Block Grant and Transportation Alternatives Program in the Transportation Management Area (TMA) to use available funding to meet needs as requested by COMPASS member agencies. One item (Safe Routes to School) requires COMPASS Board of Directors' approval, as it is a 39% increase in cost, and will be brought to the COMPASS Board for action in its December 18, 2023, meeting. The other actions will be processed through a Staff Administrative Modification.
- <u>TIP Board Administrative Modification</u>. Recommended COMPASS Board of Directors' approval of modifications to the FY2023-2029 and FY2024-2030 TIPs to increase the cost of four projects. The Safe Routes to Schools project (above) will be added to this modification. The action will be brought to the COMPASS Board of Directors for action in its December 18, 2023, meeting.
