Communities in Motion 2040 Development Review

The Community Planning Association of Southwest Idaho (COMPASS) is the metropolitan planning organization (MPO) for Ada and Canyon Counties. COMPASS has developed this review as a tool for local governments to evaluate whether land developments are consistent with the goals of *Communities in Motion 2040 (CIM 2040)*, the regional long-range transportation plan for Ada and Canyon Counties. This checklist is not intended to be prescriptive, but rather a guidance document based on CIM 2040 goals.

Recommendations

The proposal would access State Highway 55 (Karcher Road) which is the #4 priority in the Communities in Motion 2040 plan. Karcher Road serves as a multi-state, regional traveler and freight route. Traffic between Pear Lane and 10th Avenue will likely increase by 60% between 2013 and 2040, from 15,000 vehicles per day to 24,000 per day. Secondly, the highway has safety concerns have made this one of ITD's top priority routes for safety improvements. Consider requiring cross access points to adjacent properties to minimize the need for additional access points for future development.
