October Action Items:

- <u>Rural Project Priorities</u>. Adopted a resolution demonstrating approval and support for rural project priorities in Ada and Canyon Counties. COMPASS support for these priorities will provide additional points in the Local Highway Technical Assistance Council's statewide prioritization process.
- <u>FY2020-2026 TIP</u>. Adopted the FY2020–2026 Regional Transportation Improvement Program (TIP) and associated air quality conformity analysis. Final federal approval of the FY2020-2026 TIP is expected by the end of December 2019. The FY2019-2023 TIP will remain in effect until that time.
- <u>FY2020 Resource Development Plan</u>. Approved the FY2020 Resource Development Plan. This plan will be used to guide COMPASS resource development activities, such as assisting member agencies in finding and applying for grants, throughout FY2020.
