Recommendations

This location is still in a largely farmland area, several miles from schools, parks, grocery stores, and emergency services. There are no plans for public transportation to this location.

Kelly Ridge proposes a singular vehicular access point onto Purple Sage Road, an arterial roadway. The stub road will enable future vehicular circulation while limiting traffic onto arterial roads.
