Communities in Motion 2040 Development Review

The Community Planning Association of Southwest Idaho (COMPASS) is the metropolitan planning organization (MPO) for Ada and Canyon Counties. COMPASS has developed this review as a tool for local governments to evaluate whether land developments are consistent with the goals of *Communities in Motion 2040 (CIM 2040)*, the regional long-range transportation plan for Ada and Canyon Counties. This checklist is not intended to be prescriptive, but rather a guidance document based on CIM 2040 goals.

Recommendations

The location is an infill site in an employment-centric area, with thousands of jobs within a mile of the site. It is also adjacent to the College of Western Idaho. This location may reduce trip length and encourage bicycle and pedestrian use.

The proposal provides commercial and multi-family housing near a bus route, public school, public park, and grocery store. Public transportation services is approximately ¼ miles south at East Terra Linda Way. Three intercounty routes serve this location to the rest of the region. Quality pedestrian amenities are important to the success of transit ridership. Consider a safe crossing for pedestrians of Idaho Center Boulevard. Consider adding a multiuse pathway along the Purdum Gulch Drain per the 2011 Nampa Bike\Ped Plan.
