Communities in Motion 2040 2.0 Development Review

The Community Planning Association of Southwest Idaho (COMPASS) is the metropolitan planning organization (MPO) for Ada and Canyon Counties. COMPASS has developed this review as a tool for local governments to evaluate whether land developments are consistent with the goals of *Communities in Motion 2040 2.0* (CIM 2040), the regional long-range transportation plan for Ada and Canyon Counties. This checklist is not intended to be prescriptive, but rather a guidance document based on CIM 2040 2.0 goals.

Recommendations

This proposal exceeds growth forecasted for this area. Transportation infrastructure may not be able to support the new transportation demands. The proposal is on the fringe of urban development in an area removed from employment centers and existing public transportation. Bus service from the College of Western Idaho to downtown Boise is approximately one mile to the south. However, there isn't contiguous sidewalks or bicycle lanes between the two locations. Consider adding an improved multiuse pathway along the Ten Mile Creek to encourage multimodal trips in this area.

Idaho Center Boulevard, from Achievement Drive to Cherry Lane is identified in the *Communities in Motion* 2040 2.0 plan to be widened from two to five lanes, including curb, gutter, sidewalks, and bike lanes. It is the #14 local system priority in the plan and additional funding will be needed to complete this work.
