Chair Lenny Riccio called the meeting to order at 8:31 a.m.

OPEN DISCUSSION/ANNOUNCEMENTS

Karen Gallagher announced that the City of Boise will be posting two positions in their Comprehensive Planning Division.

Hunter Mulhall announced that COMPASS will begin the I-84 Corridor Operations Plan to look at Transportation Systems Management Operations (TSMO) and Intelligent Transportation Systems (ITS) strategies to help improve the operations on the I-84 corridor. Regular updates will be brought to RTAC.

CONSENT AGENDA

A. Approve November 18, 2020, RTAC Meeting Minutes

Clair Bowman moved and Ryan Head seconded approval of the Consent Agenda as presented. Motion passed with one abstention from Karen Gallagher.

ACTION ITEMS

A. Elect 2021 Chair and Vice Chair

Liisa Itkonen facilitated the election of the RTAC Chair and Vice Chair for 2021.

After discussion, Karen Gallagher moved and Clair Bowman seconded to maintain Lenny Riccio as the Chair. Motion passed unanimously. Lenny Riccio moved and Tom Ferch seconded to maintain David Corcoran as the Vice Chair. Motion passed unanimously.

B. Recommend Adoption of a Resolution Amending *Communities in Motion 2040 2.0* (CIM 2040 2.0)

Liisa Itkonen reviewed a resolution amending CIM 2040 2.0 to add an Ada County Highway District (ACHD) and Idaho Transportation Department (ITD) joint project for preliminary design and an environmental study to replace the Five Mile overpass over Interstate 84 and widen Five Mile Road, and requested RTAC recommendation for the COMPASS Board of Directors' approval.

After discussion, Ryan Head moved and Nichoel Baird Spencer moved to recommend that the COMPASS Board of Directors adopt Resolution X-2021 amending Communities in

Motion 2040 2.0 with the modification to the southern terminus as listed. Motion passed unanimously.

C. Recommend Adoption of a Resolution Amending the FY2021-FY2027 Regional Transportation Improvement Program (TIP)

Toni Tisdale reviewed a resolution to amend the FY2021-FY2027 Regional Transportation Improvement Program to add an Ada County Highway District (ACHD) and Idaho Transportation Department (ITD) joint project for preliminary design and an environmental study to replace the Five Mile overpass over Interstate 84 and widen Five Mile Road, and sought RTAC recommendation for COMPASS Board of Directors' approval.

After discussion, **Tom Ferch moved and Ryan Head seconded to recommend approval by the COMPASS Board of Directors with the modification to the southern terminus as listed. Motion passed unanimously.**

Topic: Communities in Motion 2040 2.0 and FY2021-2027 Regional Transportation Improvement Program Amendment

Request/Recommendation:

COMPASS staff requests a RTAC recommendation for COMPASS Executive Committee's adoption of resolutions (Attachments 1 and 2) amending *Communities in Motion 2040 2.0* (CIM 2040 2.0) and the FY2021-2027 Regional Transportation Improvement Program (TIP) to add a project for operational improvements on I-84, as requested by the Idaho Transportation Department.

Background/Summary:

When funding is identified to pay for new projects, the long-range transportation plan and the TIP must be amended to reflect the change and add the project(s) as "funded." Therefore, COMPASS is proposing to amend CIM 2040 2.0, as well as the FY2021-2027 TIP, as requested by the Idaho Transportation Department to add a new funded project.

Exit 25 on Interstate 84 west of Caldwell has seen an increase in traffic demand due to growth and new development in that area. This is resulting in operational concerns, specifically on the westbound off ramp during peak hours. The proposed improvements include minor widening of the westbound off ramp to reestablish uniform shoulder width, installation of a traffic signal and queue detection on the westbound ramp, and slope excavation to improve sight distance.

A public comment period on the proposed change was held February 8 through February 22, 2021. Public comments will be posted to the RTAC meeting webpage (attachments and supplemental information) at www.compassidaho.odrg/people/rtacmeetings.htm, when it is available. An email reminder will also be sent once comments are posted.

COMPASS staff will request COMPASS Executive Committee's adoption of Resolutions X-2021 and XX-2021, to amend CIM 2040 2.0 and the FY2021-2027 TIP, in its March 9, 2021, meeting. The COMPASS Board of Directors will be asked to ratify the Executive Committee's action in its April 19, 2021, meeting.

Implication (policy and/or financial):

These amendments will add one new funded project to CIM 2040 2.0 and the FY2021-2027 TIP to enable work to begin immediately.

RESOLUTION NO. X-2021

FOR THE PURPOSE OF AMENDING COMMUNITIES IN MOTION 2040 2.0

WHEREAS, the Community Planning Association of Southwest Idaho (COMPASS) has been designated by the Governor of Idaho as the metropolitan planning organization responsible for transportation planning in Ada and Canyon Counties;

WHEREAS, the Fixing America's Surface Transportation (FAST) Act, Title 23 United States Code Section 134, and Title 49 United States Code Section 5303 requires metropolitan planning organizations to prepare regional long-range transportation plans covering a period of no less than 20 years;

WHEREAS, the FAST Act, Title 23 United States Code Section 134, and Title 49 United States Code Section 5303 require projects contained in the regional long-range transportation plan to be financially constrained;

WHEREAS, COMPASS proposed an amendment to *Communities in Motion 2040 2.0* to add an Idaho Transportation Department project for improvements at Exit 25 on Interstate 84, including minor widening of the westbound off ramp to reestablish uniform shoulder width, installation of a traffic signal and queue detection on the westbound ramp, and slope excavation to improve sight distance;

WHEREAS, the FAST Act, Title 23 United States Code Section 134, and Title 49 United States Code Section 5303 requires regional long-range transportation plans be developed and amended in consultation with all interested parties; and

WHEREAS, a public comment period was held between February 8 and 22, 2021, and comments were shared with the COMPASS Board of Directors for consideration.

NOW, THEREFORE, BE IT RESOLVED, that the Community Planning Association of Southwest Idaho's Executive Committee approves the amendment to *Communities in Motion 2040 2.0*.



Topic: Federal-Aid Project Ranking

Request/Recommendation:

COMPASS staff seeks RTAC recommendation of the ranking for federal-aid projects.

Background/Summary:

Each year, COMPASS solicits funding applications for transportation needs through a two-phase approach. All applicants were required to submit a Phase I application; the deadline for Phase I applications for the FY2022-2028 funding cycle was December 7, 2020. COMPASS staff determined funding eligibility of all applications and provided that information to applicants on December 14, 2020. Members who submitted applications deemed eligible for federal-aid funding were requested to submit Phase II applications, providing additional information for the federal process, no later than January 19, 2021.

All federal-aid-eligible applications, as well as a matrix including summary information, were available for review by RTAC voting members on February 3, 2021. COMPASS staff also hosted a voluntary workshop on February 3, 2021, to review each application and provide the opportunity for questions and discussion. The ranking process, using an online paired comparison method, was open between February 3 and February 16, 2021. The preliminary ranking from the paired comparison process is provided in Attachment 1.

The number of applications submitted eligible for each federal funding program is listed below.

- Surface Transportation Block Grant Transportation Management Area (STBG-TMA) – 18
- Transportation Alternatives Program TMA (TAP-TMA) 4
- STBG-Urban (STP-U) 11

Some applications are eligible for multiple funding sources. Applications were listed in each eligible funding category during the ranking process; therefore, some projects appear under more than one category in the attached preliminary ranking.

COMPASS staff requests RTAC review of the preliminary rankings, discussion of possible changes, and a recommendation of the final rankings. The recommended rankings will guide staff in developing a funding plan for federal-aid programs. A summary of the federal-aid-eligible applications is provided in Attachment 2, for your convenience. The summary includes agency priorities, meant to assist RTAC members.

Timeline:

The timeline for development of federal-aid programs is outlined below.

- March 3, 2021 RTAC optional workshop
 - o Review federal-aid funding recommendations
- March 17, 2021 RTAC recommends draft federal-aid programs, which feed into the draft FY2022-2028 Regional Transportation Improvement Program (TIP)
- April 8, 2021 Urban Balancing (further balancing STP-U)
- May 26, 2021 RTAC reviews draft FY2022-2028 TIP
- June 21, 2021 COMPASS Board of Directors reviews draft FY2022-2028 TIP
- August 2-31, 2021 -Public comment period on draft FY2022-2028 TIP
- September 22, 2021 RTAC requested to recommend FY2022-2028 TIP
- October 18, 2021 COMPASS Board of Directors requested to approve FY2022-2028 TIP

COMPASS also has two non-federal programs, *Communities in Motion* Implementation Grants and the Project Development Program. The last opportunity to apply for funds through these programs is May 4, 2021. The rankings for these programs will be provided to RTAC on July 28, 2021, for recommendation to the COMPASS Board of Directors on August 16, 2021.

Implication (policy and/or financial):

The ranking process develops the priority order to fund new projects in all available federal-aid funding programs managed by COMPASS.

Topic: Park and Ride Study

Request/Recommendation:

This is an information item only.

Background/Summary:

In early 2020, Ada County Highway District Commuteride and COMPASS partnered in seeking consultant assistance for a regional park and ride study to inform future park and ride locations and funding decisions in the Treasure Valley. The study began in June 2020 and concluded in February 2021. The background and scope of the study were presented to RTAC in its April 22, 2020, meeting.

The park and ride study supports the use of non-single occupancy vehicle options, a congestion management strategy, and provides guidance to help maximize the use of transportation funding. To achieve the stated goals, the study included stakeholder engagement, analysis of existing and future conditions, identification of park and ride typologies and expansion opportunities, and development of siting criteria and a ranking system. A project management team was involved throughout the process to guide development of the study and provide input at key milestones.

The study results will be incorporated into *Communities in Motion 2050* and other regional planning efforts. The results will help the Treasure Valley achieve a regional connected rideshare network and increase transportation options. COMPASS will work with member agencies to establish a regional park and ride advisory group to implement recommendations from the study.

COMPASS Regional Park & Ride Study Summary

The Treasure Valley community has a vested interest in improved and expanded transportation and mobility services. Community Planning Association of Southwest Idaho (COMPASS), in partnership with regional transportation agencies, developed this study as both a long-range vision and a short-term action plan for the regional park and ride system to better serve the Treasure Valley community in keeping with goals developed in the Communities in Motion 2040 2.0 long-range transportation plan.

STUDY ORGANIZATION

FOUNDATION

The Foundation section sets the stage for actions and strategies recommended for the Treasure Valley Park and Ride System. This section discusses existing conditions of the park and ride system, influencing future conditions such as population and employment growth, financial decisions, and technological advancement, and best practices used by other agencies under similar conditions.

The system encompasses both formal facilities—those owned and/or operated by an agency providing transit or mobility service—and informal facilities, where spaces are made available by a private owner and operator. Many of the park and rides were created in an ad hoc fashion to serve a relatively small number of users. As such, while the system can effectively serve loyal users, it has limited capability to strategically respond to the growing and evolving needs of its expanding community.

Opportunites exist for: consistent signage, wayfinding & maintenance standards; amenities; first- and last-mile connections; and extended capacity.

FUTURE

The Future section outlines the recommended actions for the Treasure Valley Park and Ride System, including typology classifications, system expansion, a criteria and ranking system for future park and ride investments, and innovative funding mechanisms.

Moving forward, the Treasure Valley Park and Ride System should focus on broad classification of park and rides across three core typologies: high-density or "mobility hub", medium density, and low density, built around the typical user—their trip length, destination, first- and last-mile connection options, and unique


Future investments—whether building new park and rides or adding to existing ones—should be guided by a clear and quantifiable ranking system. The ranking system developed as part of this work includes metrics for declining, assessing, or pursuing investment opportunities.

NEXT STEPS

Over the next 1 - 2 years:

- · Standardize existing park and ride facilities
- Expanded data collection and benchmarking
- · Formalization of scoring methodology
- Continued and expanded partnerships
- Establishment of a Park and Ride Management Team

- · Continued partnership development
