August Special Items:

- Member Agency Presentation. Ada County staff presented on transportation issues important to Ada County.
- Finance Committee. Received a status report on the July 13 and August 17, 2023, Finance Committee meetings.

August Action Items:

- <u>UPWP</u>. Adopted COMPASS' FY2024 Unified Planning Work Program and Budget (UPWP). Fiscal year 2024 begins October 1, 2023.
- <u>Executive Director Annual Review</u>. Approved an increase in compensation for the COMPASS Executive Director, following a discussion in Executive Session.
- <u>CIM Implementation Grants/Project Development Program</u>. Approved two projects for FY2024 *Communities in Motion* (CIM) Implementation Grants and three projects for FY2024 Project Development Program assistance.
- <u>CIM 2050 and TIP</u>. Approved an amendment to *Communities in Motion 2050* (CIM 2050), the FY2024-2030 Regional Transportation Improvement Program (TIP), and the associated air quality conformity demonstration for northern Ada County. Final federal approval of the FY2024-2030 TIP is expected by the end of December 2023. The FY2023-2029 TIP will remain in effect until that time.

- <u>End-of-Year and Redistribution Program</u>. Approved changes to the End-of-Year and Redistribution Program, which had been previously approved by the Board in June 2023. This item was brought to the COMPASS Board of Directors for ratification via consent agenda in its August 21, 2023, meeting.
- <u>2024 State Legislative Policy Positions</u>. Discussed and provided edits to the draft 2024 Idaho legislative policy positions and directed staff to bring revised position statements back to the Executive Committee in its September 12, 2023, meeting for further review and action.

August Action Items:

- <u>CIM 2050 and FY2024-2030 TIP</u>. Recommended COMPASS Board of Directors' approval of an amendment to *Communities in Motion 2050* (CIM 2050) to add five newly funded projects and of the FY2024-2030 Regional Transportation Improvement Program (TIP) and associated air quality conformity demonstration. These items were brought to the COMPASS Board of Directors for action in its August 21, 2023, meeting (see above).
- <u>Proposal for TIP Amendment Public Comment</u>. Accepted a proposal to request public comment to add three projects to the TIP at the request of the City of Middleton and Ada County Highway District. A public comment period will be held in early September. The proposed amendment will be brought to RTAC, along with public comments received, for action in its September 27, 2023, meeting.
