August Special Items:

- Member Agency Presentation. Received an overview of the City of Garden City's high-priority transportation projects.
- Finance Committee. Received a status report on the July 10 and August 14, 2025, Finance Committee meetings.

August Action Items:

- FY2025 UPWP. Adopted Revision 3 of the FY2025 Unified Planning Work Program and Budget (UPWP).
- FY2026 UPWP. Adopted COMPASS' FY2026 UPWP. Fiscal year 2026 begins October 1, 2025.
- <u>FY2026 CIM Implementation Grants and Project Development Program Projects.</u> Approved FY2026 Communities in Motion (CIM) Implementation Grant and Project Development Program project rankings. Five projects, from the Ada County Highway District and the Cities of Caldwell, Eagle, Nampa, and Wilder, will be awarded funding. Two additional projects, from the Cities of Boise and Nampa, may also be funded if anticipated additional funding becomes available.
- <u>CIM 2050 and FY2026-2032 TIP</u>. Approved an amendment to CIM 2050 to add four newly funded projects and approved the FY2026-2032 Regional Transportation Improvement Program (TIP) project list. Final federal approval of the FY2026-2032 TIP is expected by the end of December 2025. The FY2025-2031 TIP will remain in effect until that time.
- <u>Let's Ride Treasure Valley</u>. Approved commuter rail on the Boise Cutoff alignment as the preliminary locally preferred alternative for the Let's Ride Treasure Valley Planning and Environmental Linkages study. The full completed study is anticipated to be brought to the Board of Directors for action in February 2026.

• <u>2026 State Policy Positions</u>. Discussed a legislative strategy and draft policy positions for the 2026 Idaho legislative session. The Board is anticipated to receive this item for action in its October 2025 Board meeting.
