## Communities in Motion 2040 Development Review

The Community Planning Association of Southwest Idaho (COMPASS) is the metropolitan planning organization (MPO) for Ada and Canyon Counties. COMPASS has developed this review as a tool for local governments to evaluate whether land developments are consistent with the goals of *Communities in Motion 2040 (CIM 2040)*, the regional long-range transportation plan for Ada and Canyon Counties. ## Recommendations

The proposal is in an area that is transitioning from farmland to urban development. The proposal would extend Hidden Brook Drive to North CanAda Road as a collector roadway. *Communities in Motion* 2040 plan proposes future bus service along serve Highway 44 with 30-minute frequencies with a bus stop near North Center Street.
