Communities in Motion 2040 2.0 Development Review

The Community Planning Association of Southwest Idaho (COMPASS) is the metropolitan planning organization (MPO) for Ada and Canyon Counties. COMPASS has developed this review as a tool for local governments to evaluate whether land developments are consistent with the goals of *Communities in Motion 2040 2.0* (CIM 2040), the regional long-range transportation plan for Ada and Canyon Counties. This checklist is not intended to be prescriptive, but rather a guidance document based on CIM 2040 2.0 goals.

Recommendations

The proposal would likely increase the affordable housing in an infill location, which is nearby thousands of jobs, along a bus route, and nearby to services such as a grocery store and a public park. This location may reduce trip length and encourage bicycle and pedestrian use. This proposal provide a density needed to support public transportation services. The site is currently served by bus service which runs along Northside Boulevard, with a bus stop approximately ½ mile north of the property. This route provides access from the Happy Day Transfer Center to downtown Boise. ValleyConnect 2.0 proposes additional bus frequency and changing the route to provide connections to the Boise Airport and Micron. Work with the Nampa School District to provide a safe, accessible location for school bus pick-up and drop-off on Gateway Street, rather than on Northside Boulevard.
