A. Approve Stimulus Funding Application for Rural Mobility Management

Liisa Itkonen reviewed a stimulus funding application for a rural mobility management grant to develop mobility management in 6 counties: Ada, Canyon, Boise, Owyhee, Gem, and Elmore.

After discussion, Fred Tilman moved and Tammy de Weerd seconded approval for staff to submit the application for stimulus funding for rural mobility management projects. Motion passed unanimously.

A. Review Current and Upcoming Legislative Activity

Ken Burgess provided an update on the following legislative activity:

• Enhanced Transportation Funding Legislation

The Governor has been meeting individually with members of the House Transportation Committee to reach a compromise plan on the fuel tax and registration fee increase issue. The Governor's Office has asked COMPASS Board members to contact the House Transportation Committee members and encourage them to support the compromise plan.

Local Option Sales Tax

Representative Labrador's local option vehicle registration fee bill failed and will not be brought back this session.

GARVEE

Governor Otter has said if the next installment of GARVEE is not approved, he will use stimulus dollars to fund GARVEE projects.

STAR Legislation

STAR legislation is on the Senate third reading calendar and is anticipated to pass.

Design/Build Legislation

Senator Winder has printed a new version of the Design/Build bill, SB1147. Discussions with AGC about their concerns are on-going.

HOV Legislation

Representative Jaquet is going to amend her HOV legislation to be applicable to only Highway 75.
