Nichoel Baird Spencer moved and Nathan Leigh seconded approval of the Consent Agenda as presented. Motion passed unanimously.

#### **ACTION ITEMS**

A. Appoint RTAC Subcommittee to Evaluate and Prioritize Applications for the CIM Implementation Grant Program

Don Matson discussed forming a RTAC subcommittee to evaluate and prioritize applications for the CIM Implementation Grant Program.

After discussion, Nichoel Baird Spencer moved and Nicole Nimmons seconded approval of Patricia Nilsson, Amy Schroder, and Rhonda Jalbert as Subcommittee members to evaluate CIM Implementation Grant Program applications. Motion passed unanimously.

#### B. Appoint RTAC Work Group to Recommend Timing and Scope for High Capacity Corridor Study for FY2018

Liisa Itkonen discussed forming a RTAC Work Group to recommend timing and scope of the High Capacity Corridor study for FY2018.

The purpose of the Work Group was discussed, and clarified by COMPASS staff, to include laying out all steps with costs necessary to achieve a robust public transportation system with high capacity transit.

After discussion, Nichoel Baird Spencer moved and Nathan Leigh seconded to establish a High Capacity Corridor Study Work Group with RTAC members from Ada County, Ada County Highway District, City of Boise, Canyon County, City of Eagle, ITD, City of Meridian, City of Nampa, and VRT. Motion passed unanimously.

#### C. Recommend COMPASS Board Approval to Amend the FY2015-2019 Regional Transportation Improvement Program

Toni Tisdale presented an amendment to the FY2015-2019 Regional Transportation Improvement Program as requested by the Local Highway Technical Assistance Council for the City of Nampa, the cities of Boise and Eagle, and VRT/ACHD jointly. A Public Comment period will be open March 23 – April 6, 2015.

After discussion, **Clair Bowman moved and Nichoel Baird Spencer seconded to** recommend COMPASS Board approval of the FY2015-2019 Regional Transportation Improvement Program amendment with a modification correcting the funding amount on Key No. 13514. Motion passed unanimously.

# A. Recommend FY2016 Unified Planning Work Program (UPWP) and Priorities to Finance Committee

Sabrina Anderson reviewed information from the February 2015 RTAC Workshop on the preliminary prioritization of options and work tasks for the FY2016 UPWP, and led a process using the Audience Response System to establish the highest ranked FY2016 program priorities to be recommended to the Finance Committee.

Results of the prioritization effort will be distributed to RTAC and are attached to the minutes.

Patricia Nilsson cautioned using the term "preserve agriculture land." She suggested to use the term "protect agriculture land" or "agriculture economic development plan."
