### A. Establish August 20, 2013, COMPASS Board Meeting Agenda

### INFORMATION/DISCUSSION ITEM

### A. Status Report - Idaho Transportation Board Policy B-11-04

Matt Stoll stated at its June meeting, the Idaho Transportation Board voted to maintain its current policy (B-11-04) on apportionment of Surface Transportation Program (STP) funds, and not change the apportionments per MAP-21 as recommended by the MPO Directors. Matt said he requested an accounting from the Idaho Transportation Department on how the MAP-21 apportionments in the geographic areas have been expended.

After discussion, the Committee directed Matt to work through the reauthorization of the transportation bill and have COMPASS staff conduct an analysis on how the MAP-21 apportionments in the geographic areas have been expended.

#### B. Update Strategic Plan

Matt Stoll reviewed with the Committee the recommendations they had made to date, and ideas from a brainstorming session conducted last October on services COMPASS could potentially provide to help fulfill local or regional needs. The Committee will continue to work on the update to the strategic plan at its August 20, 2013, meeting.
